## **STREET OPENING PROCEDURE FOR SEWER CONNECTION**

- Contractor is responsible for notifying PA One Call.
- Surety Road Bond: Before work begins, contractor is to provide \$2000 road bond for a period of two years (24 months) to the Emsworth Borough Office naming “Emsworth Borough” as Certificate Holder. Contractor must complete street opening application provided by the Emsworth Borough Office.
- Certificate of Insurance – Applicant shall submit Certificate of Insurance showing workers compensation insurance naming ”Emsworth Borough” as certificate holder.
- All dirt removed from excavated area is to be hauled away. Sufficient barricades, warning signs, lights/flares shall be in operation at all times when visibility is such as to warrant their use.
- Connection to Emsworth Borough main is to be made as follows:
  - o A clean cut is to be made in the main line; saddles are not permitted. Install new pipe of proper size with connection for lateral Fernco connecting with full-length stainless-steel protection are to be used for splices.
  - o Shot gravel is to be used for bedding material and 12” over new installation. Rest of fill is to be compacted material. New material is to be compacted minimum of every 18”.
  - o Street restoration is to be made by saw cutting new excavation in square with 3-1/2 of binder asphalt and 1 ½ of wear course asphalt. All edges are to be sealed with hot tar seal.
- If contractor needs to close the road during construction, contractor is to notify the Emsworth Borough Office 24 hours prior to commencement of work for road closure. After Borough Office hours, contact Allegheny County 911; to dispatch Ohio Township Police to close the road.
